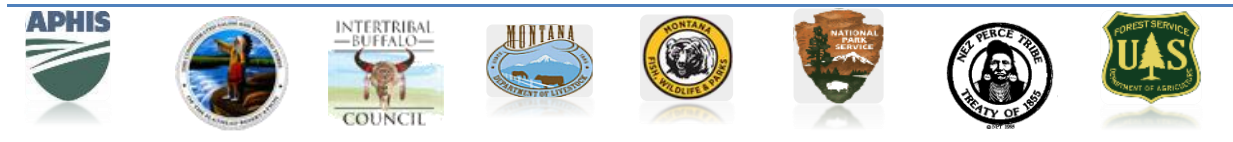


# Summary Report from the Interagency Bison Management Plan Meeting (via Zoom) December 2, 2020



**First draft presented December 22, 2020 by meeting facilitator Scott Bischke**

The following summary report reflects activities at the December 2, 2020 meeting of the Interagency Bison Management Plan (IBMP) Partners, held via Zoom teleconferencing. This report comes from the notes of facilitator Scott Bischke<sup>1</sup>. The report will be marked *Draft* until formal Partner agreement to make it *Final* at the start of their next meeting. ## Attendees

The nine Partner attendees to the Zoom telecon were Rebecca Frye (APHIS), Bing Matt (CSKT), Arnell Abold (ITBC), Mike Honeycutt (MBOL), Martin Zaluski (MDOL), Mark Deleray (MFWP), Cam Sholly (NPS-YNP), Quincy Ellenwood (NPT), and Mary Erickson (USFS). In addition to these Partners, ~60 others attended (mostly listening) on the Zoom call. Those included staff and representatives from treaty hunting tribes, as well as Shana Drimal (Greater Yellowstone Coalition) and Nathan Varley (Bear Creek Council), both of whom had been invited to make short presentations.

## General public participation

The general public was invited to join the meeting via Facebook Live. The real-time feed of the Zoom telecon was hosted on the NPT Tribal Council Facebook page. Links were provided on the IBMP website meetings pages. Several days before the meeting, a Google Form was made available for public input with a link again posted on IBMP meetings web page. A note told the public that any comments received would be sent to the IBMP Partners. Two comments were received and sent to the IBMP Partners and staff on December 3. Those public comments are also recorded at the end of this report.

## Meeting agenda, report structure

Building from their July 29 Zoom telecon experience, the Partners moved well through the 3-hr Zoom meeting, with some noting positives about such meetings (no travel, concise, shorter and to the point, no possibility of disease transmission, etc). The planning team from Lead Partner NPT sought to create a short (3 hours versus all-day format), concise agenda worthy of the discussion challenges posed by the Zoom interface. ## Meeting opening

New Lead Partner Quincy Ellenwood from the Nez Perce Tribe welcomed everyone and said he was eager to get the meeting going. Kayeloni Scott of the NPT, who was running the Zoom call, provided some guidance on Zoom chat, speaker presentations, and so on. Partners started the meeting by declaring the *draft* meeting summary from their July 2020 as *final*, and instructed the facilitator to mark it as such and post to the IBMP website.

## Short overviews from multiple agenda topics

### PARTNER WELCOMES

Partners and treaty hunting tribes each took ~3 minutes to greet everyone, and spend a bit of time discussing how the COVID-19 pandemic is continuing to impact their work and work groups. As back in July, most reported lots of Zoom meetings, restrictions to travel, and some limitations on functioning—though with continuation of the essential services required from their groups, mostly just changes in how each group services its members or the public. Some reported on the number of staff or community members that had contacted COVID-19.

### 2019/20 WINTER OPS WRAP UP

Mark Deleray provided a summary of the IBMP harvest for the 2019/20 season (Table 1; this table came from the *draft* 2020 IBMP Annual Report). Mark noted that compiling harvest was quite difficult this year. He noted that the harvest count is important in helping set management objectives for the following year. He asked the Partners to be as diligent as possible in providing accurate, timely data and asked for any additional information to improve Table 1.

**Table 1.** MFWP compilation of bison hunt harvest logs for the 2019/20 season showing *combined* totals for results on the west side (West Yellowstone) and north side (Gardiner) of YNP. Unlike past years, this year’s total is a best estimate due to incomplete reporting by some hunt agencies. MFWP was not able to separate harvest data into the two areas.

## 2020/21 WINTER OPS PLAN DEVELOPMENT

Chris Geremia provide a 3-slides summary of NPS bison removal recommendations for the winter 2020/21 bison operations (see below). These recommendations come from the following report, *Status Report on the Yellowstone Bison Population*, which was posted on the IBMP website in October 2020.

### NPS Management Recommendation Winter 2020-2021

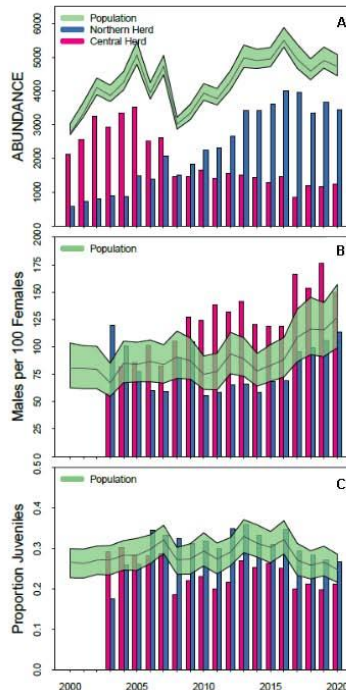
#### Recommendation Based on Population Modeling to Meet the Following Objectives:

1. Sustain a viable, wild population
2. Remove fewer than 25% of the population and less than 1,000 animals per winter when possible
3. Maintain more than 1,000 bison in the central and northern herds
4. Maintain a balanced sex ratio
5. Maintain an age structure of about 70% adults and 30% younger animals

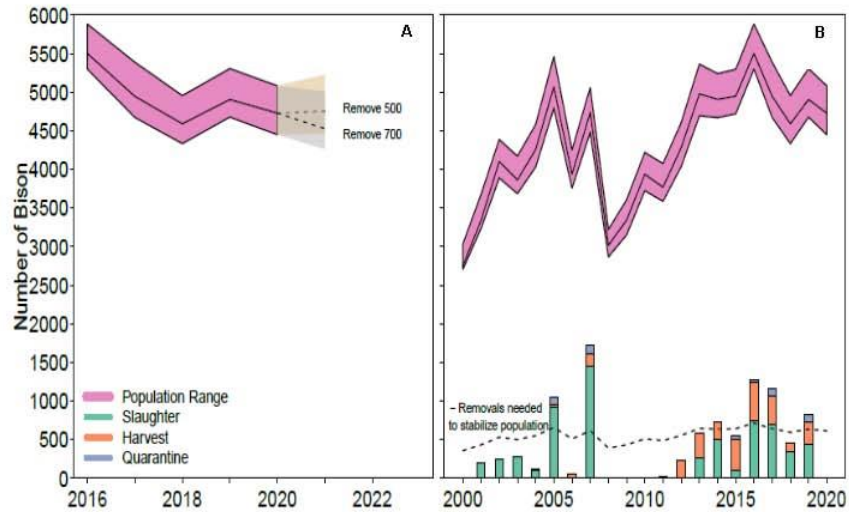
### NPS Management Recommendation Winter 2020-2021

#### Current Status:

- About 3,992 bison at the end-of-winter and about 4,730 currently. Population declined slightly from last year and stable since 2013
- Estimate 834 removed last winter biased towards adult females and younger animals
- Summer air counts near 3,400 northern herd and 1,250 central herd
- Males outnumber females about 127 males to 100 females; larger differences in central herds
- Age structure 75% adults and 25% younger animals



## NPS Management Recommendation Winter 2020-2021



### RECOMMENDATION:

1. Remove 500-700 animals
2. Limit removals to bison near the northern park boundary
3. Balance hunting and rounding up animals for transfer to slaughter
4. No space to enter new animals into the quarantine program
5. If initial removals are met, up to 200 additional males could be harvested or rounded up in late winter

### STATUS UPDATES

Partners provided key status updates on several items: a) status of carcass removal program; b) status of quarantine assurance testing capacity at Fort Peck Reservation; b) update on removing *Brucella abortus* from the CDC select agent list; c) description and current status of new bison EIS; d) updates on two lawsuits. ### PLANNING DATES FOR THE 2020 ANNUAL REPORT AND 2021 WINTER OPS PLAN

The facilitator, in conjunction with the Lead Partner, provided the following timelines for completing the Annual Report and the Winter Ops Plan:

## **Planning for 2021 (and beyond) IBMP meetings**

---

Near meeting close, Partners decided to task the facilitator with proposing meeting dates for 2021 following the meeting. In addition, a short discussion was held regarding if the three tribal entities—ITBC, CSKT, and NPT—should retain the Lead Partner role for 2021 since they were not able to host in-person IBMP meetings, as would be normal, for 2020. At their July 2020 meeting Partners thought that the three tribal groups *would* host the IBMP meetings in 2021. At this meeting, however, Partners recognized there is a real potential that due to the COVID-19 pandemic, at least the April 2021 IBMP meeting might still have to be handled as remote, Zoom calls. Again, the facilitator was asked to propose, post-meeting, a method for determining who would act as the Lead Partner in 2021.

## **Meeting close**

---

The facilitator thanked Kayeloni Scott for running the meeting. Lead Partner Quincy Ellenwood of the NPT, then thanked everyone for their time, said he appreciated the group's work and expertise, and bid all good health in the days ahead, and then closed the meeting.

## **Public comment**

---

The following public comments were received through a Google Form that was available before the IBMP meeting until midnight the day of the meeting. Each bullet is from a separate commenter.

- from Humanity -- The propaganda on your website has peaked my interest. On the surface level, it appears that your organization has the honorable mission to protect the wild Bison population and to work with native people and local communities to protect our national mammal. However, upon further investigation it appears that the Montana Department of Livestock controls wild buffalo, acting in the interest of local cattle farmers, not seeking to protect the bison or the people who have inhabited these lands long before our ancestors arrived on the shores of this continent. Research indicates that there has never been a documented case of a wild, free-roaming buffalo infecting domestic cattle with brucellosis. It would appear that you are in fact working to protect your own economic and political interests with continued disregard for the animals and the land. Land that was stolen from Native People and from native animals in order to profit the factory farming industry which is indeed the largest contributor of green-house gasses, which as a collection of organizations that claim to protect our most precious natural resources, should be of your top concern. It is beyond disheartening to learn that you are in cahoots with not only cattle interests, but also in partnership with the National Parks Service and the US Forest Service. To think organizations that are created to protect and preserve our lands are instead contributing to the degradation of the Central Herd, the animals whose descendants were here long before ours, is a travesty. We must protect the bison. It must be illegal to hunt bison. It must be illegal to send bison to slaughter. Bison are our national mammal and any actions that promotes their demise should be considered treasonous. It is time to stand true to your mission, to maintain the wild free-ranging bison population and protect this majestic species threatened with near extinction. In the words of Teddy Roosevelt, the founder of the modern conservation movement, "Defenders of the short-sighted men who in their greed and selfishness will, if permitted, rob our country of half its charm by their reckless extermination of all useful and beautiful wild things sometimes seek to champion them by saying the 'the game belongs to the people.' So it does; and not merely to the people now alive, but to the unborn people."
- From Stephaney Seay, BFC -- Both FWP and YNP have stated numerous times that the Central herd is in trouble enough so that they recommend NO HUNTING on the West side. Who is listening to them? With

this being only a suggestion it has no teeth. You decision-makers and hunt managers need to take this seriously. What are any of you doing to protect the Central herd? And Yellowstone can't just place the burden on hunters while they indiscriminately capture for slaughter or quarantine buffalo at Stephens Creek. We all know the Central herd migrates into both basins so they are doubly impacted by your mismanagement actions. And you are not fooling anyone with the greenwash name change from quarantine to "bison conservation transfer program." It's still a domestication process and buffalo still die or are eliminated from the wild. Don't pat yourselves on the back. Corridors NOT quarantine. Lastly I want to applaud Erik Holt and his words about being sick of the status quo. 5 million back on the land!
